

**GUIDELINES FOR THE ADMITTANCE OF CHURCHES
INTO THE AMERICAN BAPTIST CHURCHES OF MICHIGAN**

1. Any local church interested in admission to membership in the American Baptist Churches of Michigan shall communicate its interest in a formal letter addressed the Executive Minister of the American Baptist Churches of Michigan. This letter should include the following information:
 - a. Reason(s) for seeking admission;
 - b. A statement that this interest comes as a result of formal action as a body or through appropriate boards, according to custom of the local church;
 - c. A pledge of intended participation in the life of the area or association ministry and the larger region ministry, both personally and financially, should the church unite with the American Baptist Churches of Michigan.

2. The Executive Minister, or his/her designate, upon receipt of the letter, shall forward a copy of the letter to the appropriate area or association board and arrange a meeting of area/association board representatives with the pastor and appropriate representatives of the local church seeking affiliation, for the purpose of sharing mutual information.

3. If, following this meeting, the local church wishes to proceed toward admittance into the American Baptist Churches of Michigan, the "Application for Membership" should be completed and submitted to the Executive Minister, a copy of which shall be sent to the chairperson of the area/association.

4. Upon receipt of the "Application for Membership," the Executive Minister or his/her designate, shall initiate the following:
 - a. Work with the area/association chairperson and the local church to determine an appropriate sponsoring church from the area/association who will work with the local church for a period of at least one year providing orientation and sharing of information, services and ministries. The sponsoring church will submit reports periodically to the office of the Executive Minister and to the area/association chairperson.
 - b. Arrange for informational meetings with local church representatives in order to share current ministry programs and resources offered by the area/association, the region and the denomination. Reports from these meetings should be submitted to the chair of the area/association and the region Executive Minister.
 - c. A time line will be established for completion of the informational meetings and submission of formal recommendation to the area/association board, assuming the board receives the local congregation, then the formal recommendation to the region board.
 - d. Simultaneous with the above process, the pastor of the local church shall consult with the chairperson of the region Commission on Ordination and Standing, to begin the process of having his/her ordination recognized by the American Baptist Churches of Michigan or to meet the standards for ordination.

5. The area or association board shall review the application of the congregation seeking affiliation, the reports received from the sponsoring church, and any other appropriate information, on or about the date indicated on the previously approved time line. The area/association board will then take action on the congregation seeking affiliation. If the area/association board receives the local congregation seeking affiliation, they shall recommend to the region board the admission of said congregation.

6. Upon formal approval by the region board of the American Baptist Churches of Michigan, the local church shall be received into full membership and an appropriate ceremony of recognition shall take place: (1) at a special service of the local congregation; (2) at an area/association meeting; and (3) at the Annual Gathering of the region.

The above guidelines are in keeping with the Region Bylaws, Article V, Section 2.

**ADMITTANCE OF CHURCHES INTO THE
AMERICAN BAPTIST CHURCHES OF MICHIGAN**

THE ROLE OF THE SPONSORING CHURCH

When a local church seeks to affiliate with the American Baptist Churches, USA, through the American Baptist Churches of Michigan, the point of entry is through the region area/association through which the church makes application for membership. The area/association chairperson and/or board will, upon receipt of “application for membership,” determine an appropriate sponsoring church from the area/association who will work with the local church for a period of at least one year.

Suggested events and activities during the year of sponsorship, may include:

1. Developing a collegial relationship between the pastors of both churches that could include the sharing of resources as well as information and invitation to participate in programs and events sponsored by the area/association, region or denomination, especially directed toward the resourcing and equipping of pastors.
2. Engaging in 2-3 programs and/or events that would bring the two congregations together for sharing and fellowship. For example: a potluck or church picnic, a joint worship experience, a pulpit exchange or exchange of choirs or music groups, a combined youth event, a leader training event, etc.
3. Encouraging the church seeking affiliation to be aware of and participate in programs and events of the area/association and the region.
4. Reporting to the chairperson of the area/association on the progress of the church seeking affiliation.
5. Sharing with the region staff, especially the region Executive Minister, any questions and/or concerns that might arise and which could help the church seeking affiliation to become more informed and involved in region ministries.
