Following, you will find the 2011 Professional Registry Questionnaire. If you wish to be listed in the 2011 Professional Registry of the American Baptist Churches of Michigan, you must complete and return the questionnaire no later than **January 15, 2011**. Failure to complete and return the questionnaire **each year** may affect your listing in the ABCUSA directory.

If you completed the form last year, and your name is listed in the 2010 Registry, and your status or information has **not** changed, please fill out the first part of the questionnaire and then check the box marked, “No Change.”

If you did not return a questionnaire last year, or your name does not appear in the 2010 Registry, you must complete the entire form. You may access the 2010 Professional Registry at www.abc-mi.org by clicking on “Document Library” (located on the left-hand column). Find, “Licensing and Ordination Information” and click on, “2010 Professional Registry.”

Any professional church leader (ordained or non-ordained) is welcome and encouraged to fill out the questionnaire, provided you meet the following qualifications:

- You hold membership in an American Baptist Church affiliated with the American Baptist Churches of Michigan;
- You are serving in a professional capacity in an American Baptist church or ministry related setting at least twenty hours per week;
- You receive some monetary remuneration for your service.

Exceptions to the 20 hour / remuneration rule are licensed candidates, seminary students, retired clergy, and those who are currently waiting for placement. However, persons in these categories must return a completed questionnaire.
